WRIT DENIED.

The applicants, Nouri Ed Hakim, Joseph H. Hakim, Abraham Nouri Hakim, Leah Raquel Hakim Goldenberg, Jack Allen Hakim, Joseph Daniel Hakim, Abraham Joseph Hakim, Louise Hakim Moore, Kay Hakim Lahasky, Hannah Hakim Jones, and other related parties and companies to Luv N' Care, Ltd., ("LNC"), seek review of the trial court's October 3, 2024, ruling granting in part plaintiffs' "Motion Seeking Discovery and Relief by Contradictory Hearing pursuant to C.E. art. 508." On the showing made, we decline to exercise this Court's supervisory jurisdiction but note this ruling in no way impinges on the duties arising from the Louisiana Rules of Professional Conduct nor does it limit any corresponding objection and refusal to provide answers to any questions which would be violative of the duties of confidentiality within the attorney-client relationship. Accordingly, this writ is hereby denied.
